Dear Parent (s):

Chelsea Children's Cooperative Preschool is excited to offer a 2 year old Parent and Child Playgroup. The class is a 1 ½ hour class held in the Young 5's classroom, led by Ms. Kiera Pearce.

The 2 year old program provides families with a parent-child activity for the child who is not quite old enough to attend the traditional preschool. It also gives parents a means to connect with other parents as well as provide some "preschool experience" to both parent and child so that the transition to the 3 year old preschool will be less intimidating. Parents and children stay for the entire class.

Children enrolling in the 2 year old program must be 2 years old by September 1st of the school year. Two Sessions are available: an **October-January session** on **Friday mornings** from **9:15-10:45 a.m.** and a **January-April session** on **Friday mornings** from **9:15-10:45 a.m.** The cost is \$80.00 for each 12-week session. Families enrolling multiple children in the 2's program are eligible for a \$10 discount per additional sibling per 12-week session.

Along with this letter you will find an application. If you are interested in joining this program, please mail or deliver the completed and signed application along with a \$20.00 deposit, per 12-week session, to the Membership Chairperson as soon as possible. Your \$20.00 deposit is non-refundable and will be applied towards your \$80 tuition. The remaining tuition is due before the session begins.

We accept members on a first come, first serve basis. If a session is full your child can be placed on a waiting list for the first available opening. Participating in the 2 year old program will provide you priority enrollment for the following school year .
